The ornamental design for a Halloween sign, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a Halloween sign showing my new design;

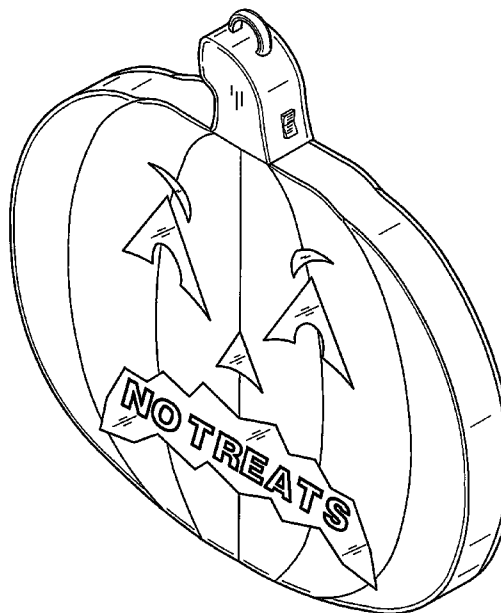
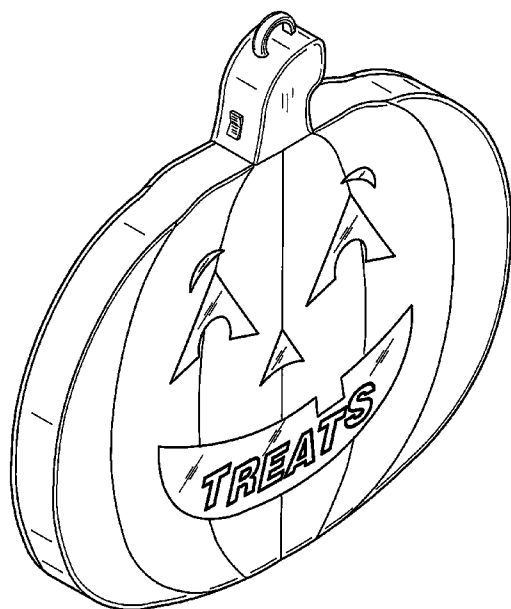

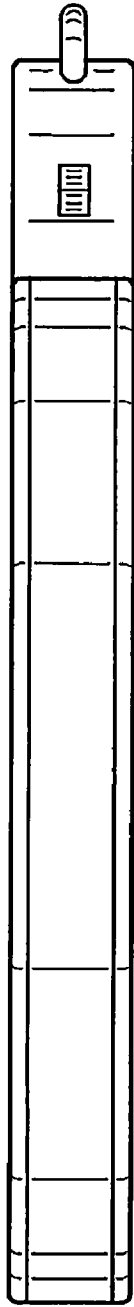

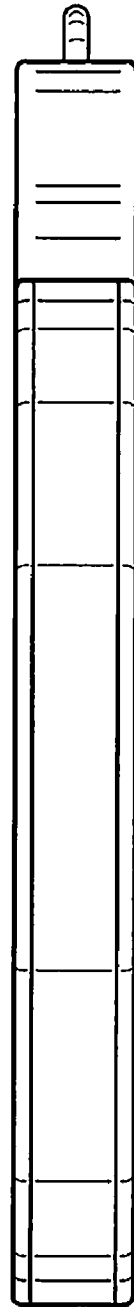

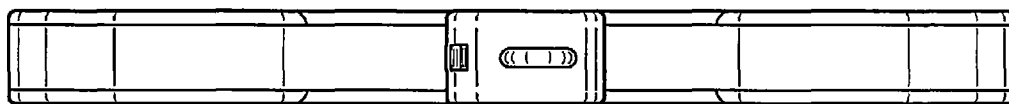

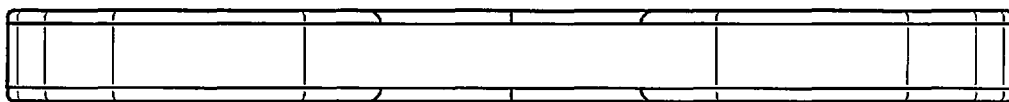

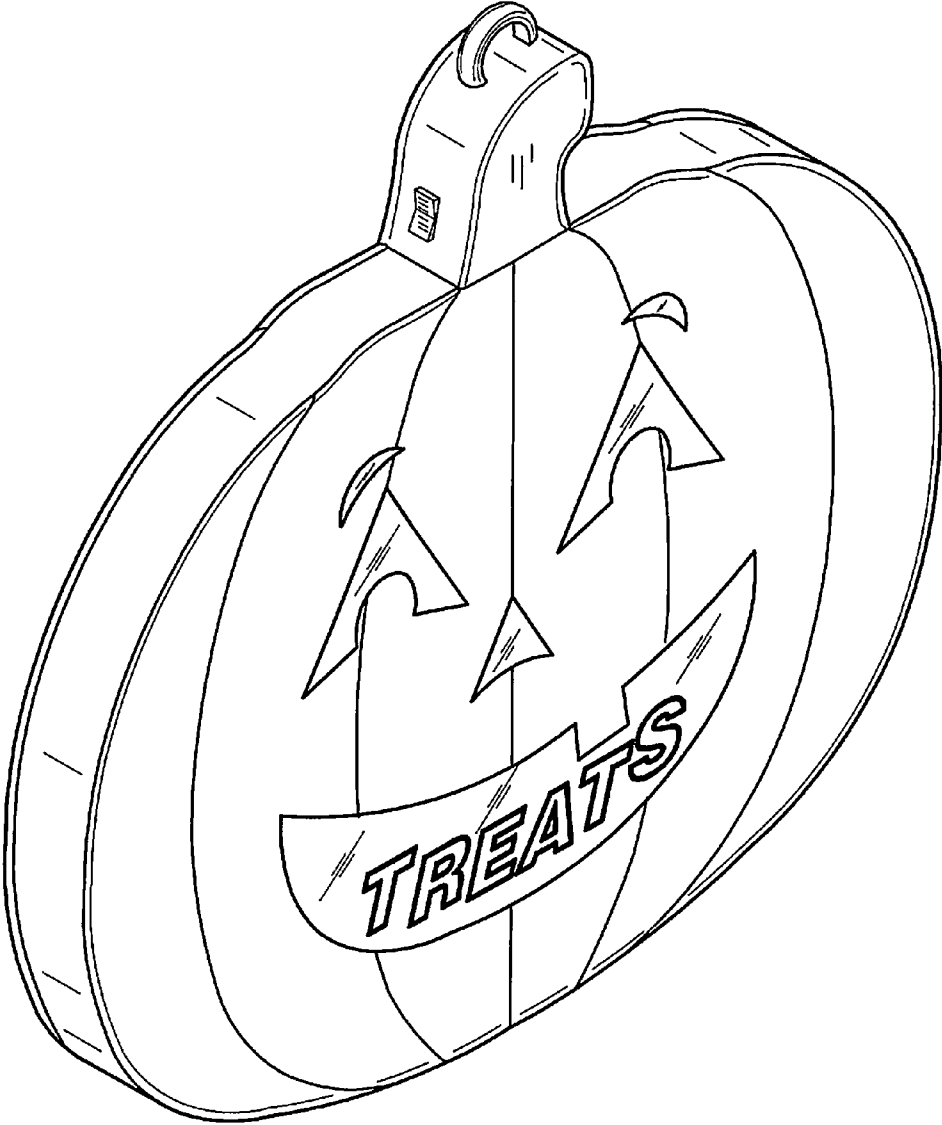

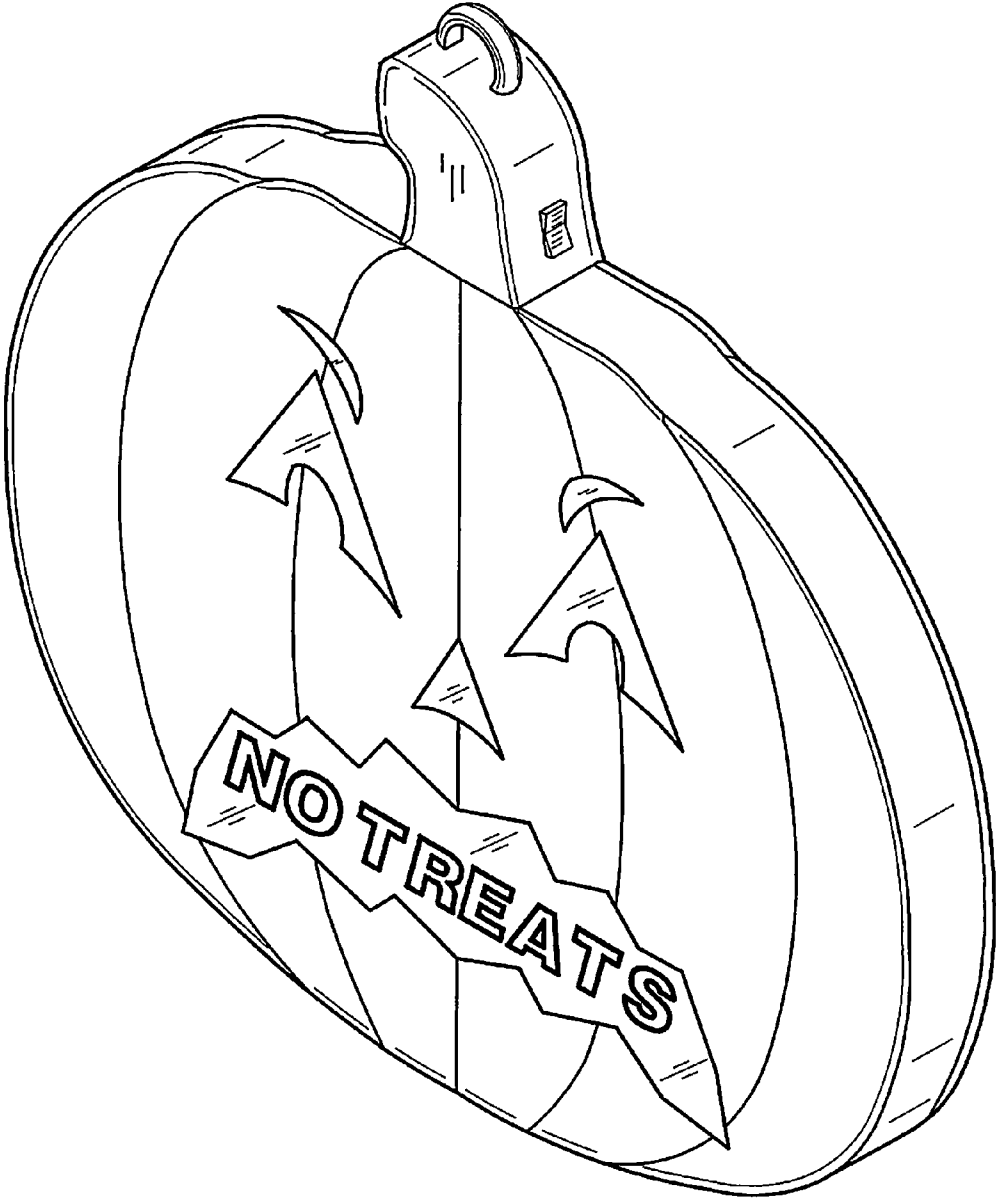
