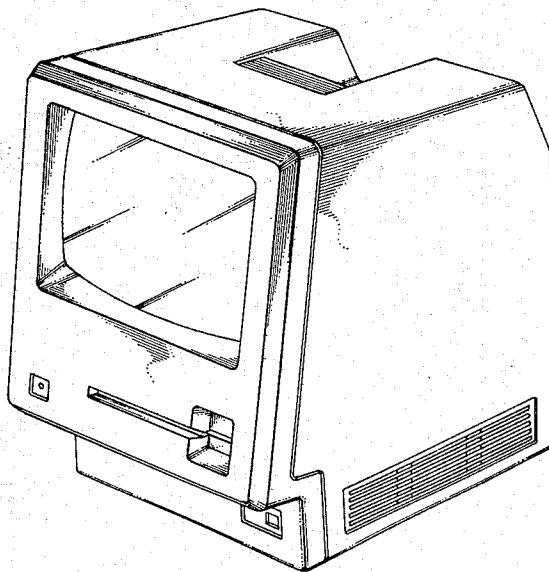

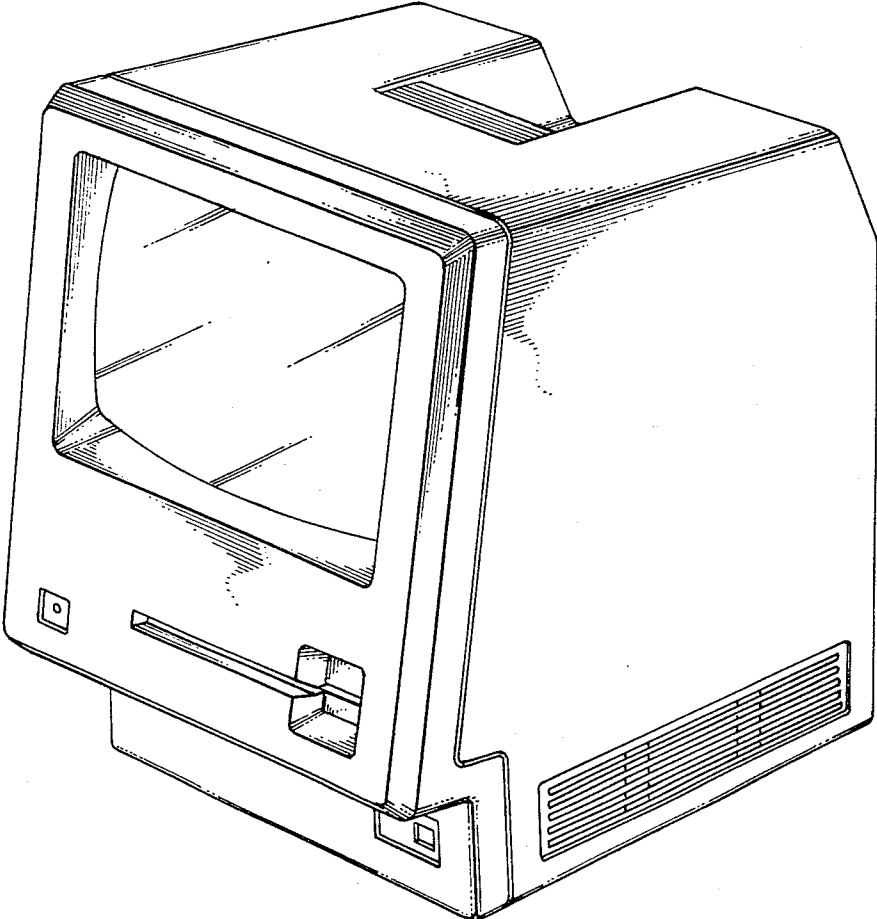
CLAIM

[57] The ornamental design for a computer housing, substantially as shown.

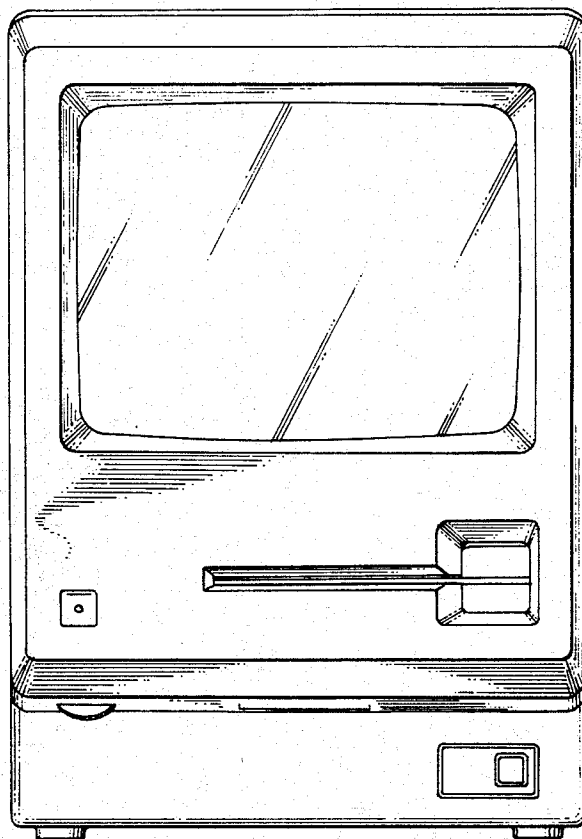
DESCRIPTION

FIG. 6 is a rear elevational view thereof.

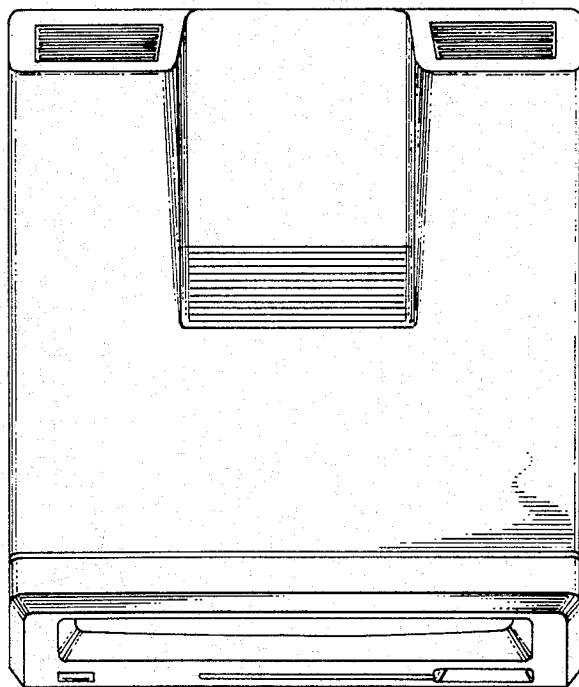




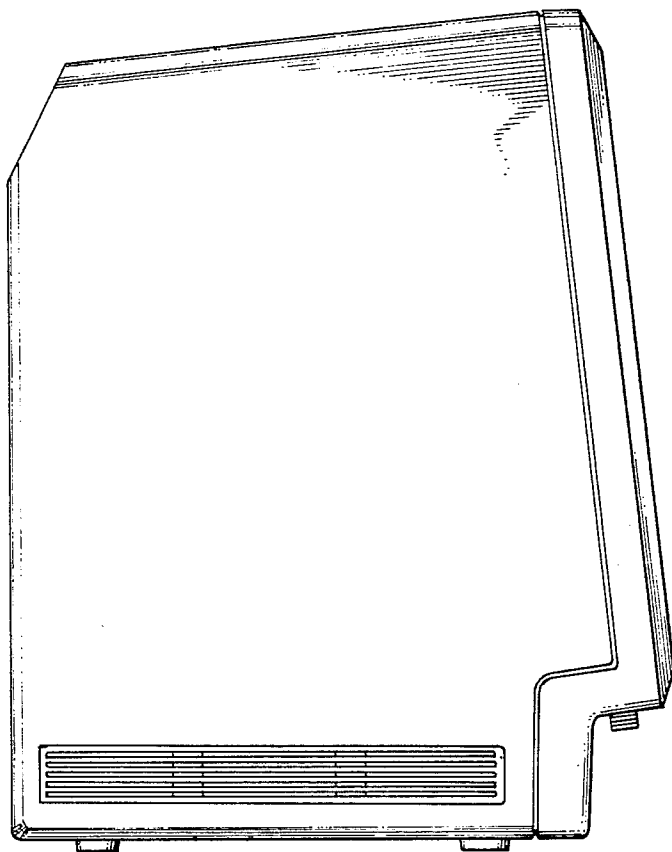

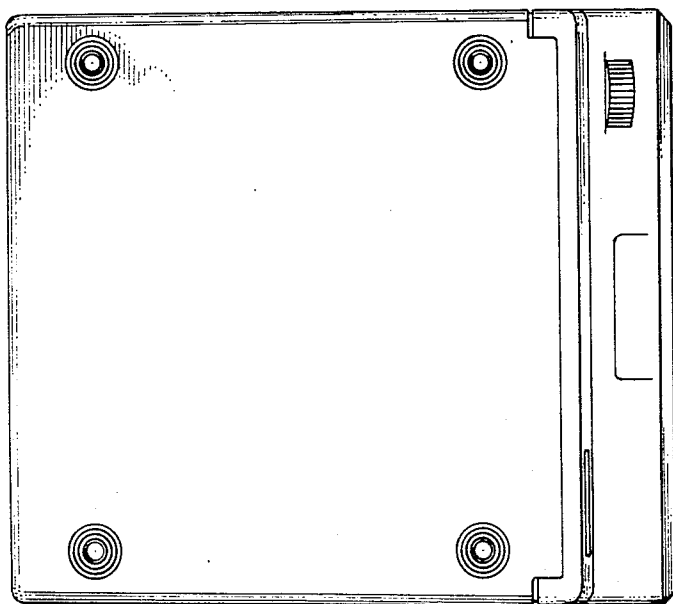

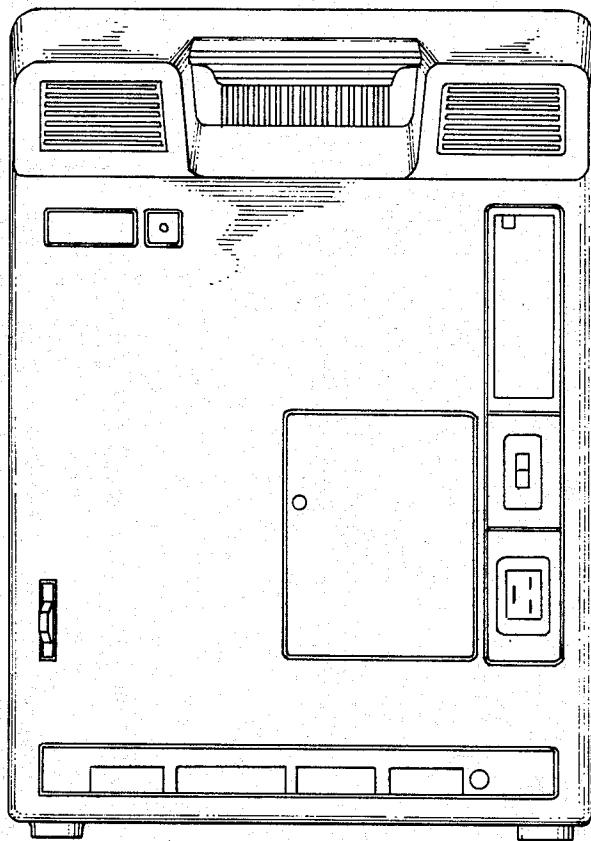
